### **ACHIEVEMENTS REPORT RELEASED\***

The final annual Achievements Report for the project, “Market Relevant Codes and Communication Leadership” is now available at [www.nfacc.ca/achievement-reports](http://www.nfacc.ca/achievement-reports). This report summarizes how NFACC is delivering leadership on farm animal care. Five new Codes were released from 2016-2018, illustrating NFACC’s track record of success. Harnessing the strengths of diversity and consensus-based collaboration, NFACC’s approach maximizes the opportunity to make better and more sustainable decisions on animal welfare. These efforts are fundamental for building public trust relative to farm animal welfare.

### **MAINTAINING THE INTEGRITY OF THE PUBLIC COMMENT PERIOD FOR CODES\***

NFACC is continually aiming higher to enhance its already robust processes. An internal review of the Public Comment Period process has been completed. The resulting recommendations will further enhance how public feedback is invited, received, and incorporated into the Code development process.

Going forward expect:

- Earlier and additional opportunities to participate in the Code development process
- A process that is more navigable, making it easier to provide input
- Improved acknowledgement that your feedback was received.

## NEW SCIENTIFIC COMMITTEE REPORT RELEASED ON ANIMAL WELFARE DURING TRANSPORTATION

The report, “Code of Practice for the Care and Handling of Farm Animals: Transportation, Review of Scientific Research on Priority Welfare Issues” is available at [www.nfacc.ca/transportation-code-of-practice-update](http://www.nfacc.ca/transportation-code-of-practice-update).

This peer-reviewed report synthesizes the results of research related to key animal welfare issues during transportation. Species covered included cattle, pigs, poultry, sheep, and equine. The Scientific Committee focused on the effect of transport duration, time off feed and water, rest intervals (where appropriate by species), environmental conditions, and loading density, as single factors or in combination, on animal welfare.

- Transportation Code (2001) – stakeholders across the transportation continuum support the update of this Code
- Goat Code (2013)
- Dairy Cattle (2009)
- Aquaculture/Fish Welfare – NEW!

Note: The process for developing or updating Codes of Practice for the Care and Handling of Farm Animals is not sustained on an ongoing basis. NFACC applies for project funding for every Code that is developed or updated.
